# REVISTA FUENTES EL REVENTÓN ENERGÉTICO GUIDELINES FOR WRITERS

Fuentes, is a scientific journal devoted in the area of energy resources, especially oil, petrochemical and carbochemical, new options for fuels, new materials and technologies of composite materials. It is a means of dissemination the research work done at the School of Petroleum Engineering and other schools of the Universidad Industrial de Santander, as well as researchers from other national and international institutions of prestige. Fuentes, is published twice a year and publishes original results of research projects, articles of reflection and review articles that show the progress and development trends in energy resources. In addition, Fuentes presents articles on technical and methodological experiences and short notes, particularly on university academic activity. All articles received by the editorial committee are subject to review by local and / or foreign referees.

The following are guidelines to be followed by authors, before submitting their articles to the Editorial committee of the Revista Fuentes:

- 1. Authors agree that:
- All authors agree with the content, organization and presentation of the manuscript
- This article is original unpublished and has not been submitted simultaneously to the consideration of other magazines or journals, while it is in review by the Editorial committee of the Revista Fuentes
- Authorize the publication of the manuscript, if accepted, under the stablished conditions by the journal publishers
- Have permission to reproduce text, images or any other material that is subject to copyrights and attach a copy
  of the authorization
- 2. The article file must be created in a word processor compatible with Microsoft Word. The figures must be in any of the following formats: tiff, gif, jpeg with a resolution greater than 300 dpi. All the files (article and figures) must be submitted to rfuentes@uis.edu.co with a copy to revistafuentes@gmail.com
- 3. Attach, completely filled out, the Transfer of Copyright agreement and the Conflict of Interest Statement, which ones must be asked to rfuentes@uis.edu.co

# **ARTICLE PRESENTATION**

## 1. GENERAL CONSIDERATIONS

The article must use international system of units (SIU) or the corresponding conversion factors table. It must be 8 pages at the most (16 sides). In double column, single spaced, in English or Spanish, in letter size, all in Times New Roman 11 point, except header whose font size is 14 points, the authors 12 points, the figures and tables titles will have a font size of 10 points.

# 2. TITLE AND AUTHORS

On the first page it must be included the title in Spanish and in English, it must not exceed 20 words. It must describe the contents of the article clearly and concisely, avoiding the use of ambiguous words, abbreviations, question and exclamation marks.

Author is considered everyone who has contributed significantly to the design and conduct of the study and the analysis of results, drafting the manuscript, the review and approval of it.

When it is necessary, it will be specified the work done by each of the authors, and the author who had overall responsibility for the study and manuscript. The name of the authors must be after the title, in capital letter; in priority order, this order will be indicated by a number in superscript at the end of each name.

Example: MANUEL JOSÉ QUIÑONEZ GARCIA<sup>1</sup>, LUZ ESTELLA GARNICA GOMEZ<sup>2</sup>

For each of the authors that appear in the header, must provide: research group or faculty, university or institute, mailing address, city and country. This information will be as page footer in the first page of the article.

Example: Escuela de Ingeniería de Petróleos, Universidad Industrial de Santander, UIS, Carrera 27 calle 9, Bucaramanga, Colombia

It is necessary to indicate which author is responsible for receiving and sending mail, otherwise we will assume that the first author will take that function. This indication will be done by means of an asterisk next to the number that indicates the priority order and with a text in font size of 9 poinst.

Example: MANUEL JOSÉ QUIÑONEZ GARCIA<sup>1\*</sup>, LUZ ESTELLA GARNICA GOMEZ<sup>2</sup> \* To whom correspondence should be addressed

#### 2.1 Conflict of Interest Statement

If the author consider necessary, the manuscripts will include, in the title page, a statement in which the authors manifest that they are independent from the financing and support institutions, and that during the execution of work or writing the manuscript interests or values have not affected the research. Only manuscripts in which the authors have no conflict of interest are considered.

In some cases it is necessary that authors specify the support received (financial, equipment, personnel work, in kind, etc..) from people, public or private institutions for the study and as well as the personal and institucional relationships that may influence the conduct, results, interpretation of the data and the drafting of the manuscript.

Editor and Editorial Committee will look at potential conflicts of interest that may affect the capability of reviewers or that make unsuitable for evaluating a particular manuscript.

Editor, Editorial Committee or reviewers are formally declared disabled to use for private or individual, the information obtained or gained in working with manuscripts.

## 3. ABSTRACTS AND KEYWORDS

They must be submitted in English and Spanish. The keywords will be at the end of the summary, minimum 3 and maximum 10. Only use as keywords those accepted by international databases.

When manuscript contains research results or it is an innovation manuscript, the abstract must be analytical, namely, it must include quantitative and qualitative information, its purpose, scope, methods used, results, conclusions and recommendations. The abstract must not contain information or aspects that are not covered in the text, abbreviations, references to the text or bibliographic references. It must be written in third person. The content of an analytical abstract must have the following aspects of the original document: objectives, methodology, results, and conclusions.

#### 4. ABOUT THE BODY OF ARTICLE

#### 4.1 ABBREVIATIONS:

For the treatment of abbreviations, the first time that they appear in the text, they should be in brackets after their full expression.

#### 4.2 FORMULAS:

The subscripts and superscripts in formulas should be clearly indicated. The numbers that identify the equations should be in parentheses at the right side to them.

# 4.3 Tables and Charts:

The tables contain text and numeric values, the charts contain only text. All tables and charts should be prepared in a table format of a word processor. Tables are not accepted as image format.

Each of the tables and charts will be cited in the text with initial capital letter, number and in the order that they appear; column headings should be brief, with units of measurement in parentheses.

Tables should be self-explanatory and not duplicate that what was stated in the text, but that substitute or complement it. Abbreviations used in the headings should be explained in the footnotes of the table and be identified exclusively with superscript lowercase letters. They should be submitted only as visible horizontal lines, simple and in black color.

Do not place the percent sign (%) or any other symbol in the cell where you place numerical values, but in the headers.

Tables should be part of the electronic file together to the manuscript and the other components. The table title must be in the top of it.

## 4.4 FIGURES.

All photos, graphics, maps, diagrams, drawings, are used to illustrate or expand the information, not for duplicate it.

All graphics, photos, drawings will be called figures. They must be cited in the text with initial capital letter, identified by an Arabic number in the order that they appear in bold. The title of the figure must be included in the bottom of it, as well as abbreviations and symbols used.

If it is possible, all figures should be designed in black and white, grayscale or similar and in high resolution and quality.

Figures, photos, drawings, etc., which have not been produced by the authors or have been taken from a magazine, book, website or similar, for which there are copyright or similar means shall be accompanied by written authorization by the publisher or respective authors or mention the bibliographic citation.

## 5. REFERENCES AND BIBLIOGRAPHIC CITES

#### 5.1 CITATION

The citation system of the journal is the suggested by American Psychological Association-APA-Publication Manual. The citation gives information about author and publication year, it is used in parentheses into the text. Do not put cites in the form of footnotes or at the end of the text.

There are two ways to cite, depending of which is the purpose:

- Textual cite: Make reference to fragments or textual ideas taken from a text, in this type of cites is necessary to put author surname, publication year and page of the text where the cite was taken.
- Cite of paraphrasing: This is the type of cite that use the author ideas, but in own words of writer. Is necessary to include in cite: author surname and publication year.

#### 5.2 BIBLIOGRAPHIC REFERENCES

The reference list is placed on a separate sheet at the end of the article, just include the cites used by writer in the paper development which must appear cited in the text.

Do not include as reference:

- Documents or abstracts unpublished, even if they have been presented in conferences or congresses.
- Articles submitted for publication that have not been accepted
- Reviews of books.

For more information about how to cite and reference, the authors should consult the APA Publication Manual. For reasons of international indexation, the references of the manuscript should be free of formatting errors. Otherwise, the material will be returned.

# 6. ABOUT THE MANUSCRIPT EVALUATION

When the manuscript is received, the evaluation processes begins. This one is as follow.

- Article first review is performed to verify compliance with this guide
- After the verification of compliance with the requirements, the manuscript is sent for peer review.
- Evaluators report to the Editor, any of the following concepts, in addition they can indicate some observations which the authors must take into account.
- a. Approved without modifications
- b. Approved with minor corrections
- c. Approved with major corrections
- d. Not approved

- The results of the evaluation are formally communicated to the authors to perform the necessary adjustments or indeed they send the justification of the changes that will not be made. (only if the concept is a,b or c, above)
- Once the authors perform the adjustments or send the justification when they do not them, another internal review is done.
- Finally, the document is reviewed by the Editorial Committee, which determine the manuscripts that will be published or not in Fuentes.
